MOTION OF LEISURE PROPERTIES LLC D/B/A CROWNLINE BOATS TO RE-OPEN DOCKET AND SUBSTITUTE PARTY

Comes now Leisure Properties LLC d/b/a Crownline Boats ("Leisure"), by and through its attorney, pursuant to 35 Ill. Adm. Code § 101.500, and respectfully submits this Motion to Re-open Docket Number AS 04-01 and substitute Leisure Properties LLC d/b/a Crownline Boats as holder of the Adjusted Standard. In support of this Motion, Leisure states:

- 1. On December 5, 2003, Crownline Boats, Inc. filed a petition with the Illinois Pollution Control Board ("Board") for an adjusted standard from 35 Ill. Adm. Code § 215.301, commonly known as the "8 lb/hr Rule." This regulation relates to the emissions of volatile organic material. The petition sought an adjusted standard for Crownline Boats, Inc.'s fiberglass boat manufacturing facility at 11884 Country Club Road, West Frankfort, Franklin County, Illinois (the "Adjusted Standard").
- 2. The Board held a hearing on Crownline Boats, Inc.'s petition on April 23, 2003. On July 22, 2004, the Board issued an Opinion and Order finding that Crownline Boats, Inc. provided sufficient justification pursuant to 415 ILCS 5/28.1 for the Adjusted Standard and granted the request.
- 3. Like many companies, Crownline Boats, Inc. experienced financial strain during the economic downturn of the recent years. On June 16, 2009, the assets of Crownline Boats, Inc., including the fiberglass boat manufacturing facility in West Frankfort, Franklin County, Illinois, were transferred to a trustee. These assets included a leasehold interest in the property

on which the West Frankfort facility was located. <u>See</u> Affidavit of Guy W. Coons, attached as Exhibit 1 ("Coons Affidavit").

- 4. On August 20, 2009, through their agent Churchill Financial LLC, certain lenders of Crownline Boats, Inc. (the "Lenders") purchased title to those assets, including the West Frankfort facility. On August 20, 2009, the Lenders sold all of the assets of Crownline Boats, Inc. to Leisure Properties LLC. Since this time, the West Frankfort manufacturing facility has been operated by Leisure Properties LLC d/b/a Crownline Boats. 1/ See Coons Affidavit.
- 5. Crownline Boats, Inc. was involuntarily dissolved on December 4, 2009. See Illinois Secretary of State Report attached as Exhibit 2. Accordingly, Leisure is filing this Motion as successor-in-interest to the assets of Crownline Boats, Inc., which include the Adjusted Standard.
- 6. Leisure has operated the West Frankfort facility in substantially the same manner as did Crownline Boats, Inc. A significant number of the employees involved in operating the West Frankfort facility for Leisure were also involved in operating the facility for Crownline Boats, Inc. See Coons Affidavit.
- 7. Although the ownership of the West Frankfort facility has changed, none of the factors justifying the Board's issuance of the Adjusted Standard have changed. Accordingly, Leisure, as the successor to the assets of Crownline Boats, Inc., requests that the Board substitute it as the recipient of the Adjusted Standard issued to Crownline Boats, Inc. on July 22, 2004. Leisure requests that this substitution be made effective as of August 20, 2009.
- 8. Leisure has operated the fiberglass boat manufacturing location in West Frankfort, Illinois in accordance with the Adjusted Standard, and intends to continue doing so. If

Additionally, on July 26, 2010, the real estate on which the West Frankfort facility is located was purchased by Dreams Come True LLC, which has the same ownership as Leisure Properties LLC. See Coons Affidavit.

operations change in the future, Leisure will ensure that all necessary environmental permitting,

including any revisions to the Adjusted Standard, are obtained. See Coons Affidavit.

9. The Board has granted similar requests to re-open Adjusted Standard dockets to

substitute a new party as the holder of an adjusted standard. See, e.g., Supplemental Opinion and

Order of the Board, In re: Petition of Cromwell-Phoenix, Inc., AS 03-05 (Nov. 20, 2003);

Supplemental Opinion and Order of the Board, In re: Petition of The Ensign-Bickford Company,

AS 00-5 (June 5, 2003); Opinion and Order of the Board, In re: Petition of Commonwealth

Edison Company, AS 96-10 (Mar. 16, 2000).

10. Counsel for Leisure has discussed this motion with the attorney for the Illinois

EPA in the adjusted standard petition matter, Charles Matoesian.

WHEREFORE, movant requests that the Board reopen docket number AS 04-01 and

substitute Leisure Properties LLC d/b/a Crownline Boats as the recipient of the Adjusted

Standard as of August 20, 2009.

AFFIDAVIT OF GUY W. COONS

I, Guy W. Coons, being first duly sworn under oath, depose and state as follows:

- 1. I am the Chief Financial Officer of Leisure Properties LLC d/b/a Crownline Boats, and have served in that capacity since August 24, 2009.
- 2. Leisure Properties LLC d/b/a Crownline Boats is a Delaware LLC located in West Frankfort, Illinois.
- 3. Prior to my role as CFO of Leisure Properties d/b/a Crownline Boats, I served as Chief Financial Officer and Director of Finance of Crownline Boats, Inc. I was employed by Crownline Boats, Inc. from approximately April 2001 until February 2009.
- 4. On June 16, 2009, the assets of Crownline Boats, Inc., including the fiberglass boat manufacturing facility in West Frankfort, Franklin County, Illinois, were transferred to a trustee. These assets included a leasehold interest in the property on which the West Frankfort facility was located.
- 5. On August 20, 2009, through their agent Churchill Financial LLC, certain lendors of Crownline Boats, Inc. (the "Lendors") purchased title to those assets, including the West Frankfort facility.
- 6. On August 20, 2009, the Lendors sold all of the assets of Crownline Boats, Inc. to Leisure Properties LLC. Since this time, the West Frankfort manufacturing facility has been operated by Leisure Properties LLC d/b/a Crownline Boats.

7. Crownline Boats, Inc. was dissolved involuntarily on December 4, 2009.

8. Leisure Properties LLC d/b/a Crownline Boats has operated the West Frankfort

facility in substantially the same manner as did Crownline Boats, Inc. A significant number of

the employees involved in operating the West Frankfort facility for Leisure Properties LLC d/b/a

Crownline Boats were also involved in operating the facility for Crownline Boats, Inc.

9. Leisure Properties LLC d/b/a Crownline Boats has operated the West Frankfort

facility in accordance with the Adjusted Standard, and intends to continue doing so. If

operations change in the future, Leisure Properties LLC d/b/a Crownline Boats will ensure that

all necessary environmental permitting, including any revisions to the Adjusted Standard, are

obtained.

10. On July 26, 2010, the real estate on which the West Frankfort facility is located

was purchased by Dreams Come True LLC, which has the same ownership as Leisure Properties

LLC.
