

HEARING OFFICER ORDER

On August 19, 2010, all parties participated in a telephonic status conference with the hearing officer. The complainant stated that it is continuing with settlement discussions with all parties. Stipulations and proposals for settlement as to both respondents are being circulated for review. By agreement, the respondents' answers are now due to be filed on or before September 24, 2010, if needed.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on September 23, 2010, at 9:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


