I am a resident of Dekalb, Illinois, and I have serious concerns about the expansion of the DeKalb County Landfill requested by Waste Management. I do not feel that the environmental effects of the expanded landfill, which will take trash from seventeen counties, have been adequately studied.

Here are some of my concerns:

- * How will the traffic for the 2,000 tons of trash per day not negatively affect I-88?
- * How will the mercury—from batteries, fluorescent lights, thermometers, cell phones, and computers in the landfill—be handled so it's not in the air or the water?
- * How will the hydrogen sulfide from the landfill not endanger children in Cortland School, which is one quarter mile from the expanded landfill?

I ask that you conduct further environmental studies on the landfill and on the air quality of the school. This issue should not be about raising revenue for DeKalb County. It should be about ensuring the best environmental and safety standards are being put into practice for Illinois citizens.
