

MOTION FOR LEAVE TO FILE REDUCED NUMBER OF COPIES OF RECORD

NOW COMES, Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY, *ex rel.* Lisa Madigan, Attorney General of the State of Illinois, and moves for leave to file a reduced number of copies of the record of decision for the subject permit, and states as follows:

1. Section 101.302(h) of the Board's Procedural Rules, 35 Ill. Adm. Code 101.302 (h), states that the Illinois EPA is to file a signed original and 9 duplicate copies of the record.
2. The record in this matter consists of 540 pages. Due to technology system constraints, electronic filing of the record is not reasonably possible. Duplication of the record would be both time consuming and a strain on State resources. Respondent requests the Board's consideration of a reduction in the number of copies required.
3. Respondent requests that the Board accept an original and two (2) copies of the record in this matter. Respondent will also serve a copy of the record of decision on Petitioner KCBX Terminals Company.


