
HEARING OFFICER ORDER

On June 22, 2011, all parties participated in a telephonic status conference with the hearing officer. Discussions centered on a hearing date and a possible waiver of the statutory decision deadline. The petitioner confirmed that it will file an additional extension of the statutory decision deadline to and including October 20, 2011. To that end, possible hearing dates of August 4, 8, 9, 10 or 11, 2011, will be discussed at the next status conference.

Due to the possibility of a hearing on August 4, 2011, the respondent must file its recommendation electronically or by facsimile on or before July 5, 2011.

The parties or their legal representatives are reminded and directed to appear at a telephonic status conference with the hearing officer on June 30, 2011, at 11:00 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




