HEARING OFFICER ORDER

The parties or their legal representatives are directed to appear at a telephonic pre-hearing conference with the hearing officer on July 21, 2011, at 9:00 a.m. The telephonic conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
