**JOINT MOTION FOR EXTENSION OF TIME**

NOW COMES Petitioner, EXXONMOBIL OIL CORPORATION ("Petitioner"), and Respondent, the ILLINOIS ENVIRONMENTAL PROTECTION AGENCY ("Illinois EPA") and hereby request an extension of time for Illinois EPA to file its recommendation in this matter. In support of this Joint Motion, Petitioner and Respondent state as follows:

1. On May 18, 2011, Petitioner filed a Petition for Review for a variance from the December 31, 2014 deadline for compliance with the applicable requirements of 35 III. Admin. Code Part 217, Subparts A, D, E, F, and Appendix H ("NOx RACT Rule").
2. On May 23, 2011, the Board accepted the Petition, and, in its discretion, concluded that a hearing would be advisable. The Board directed that this matter proceed to hearing as expeditiously as practicable. Board Order, *ExxonMobil Oil Corporation v. Illinois EPA*, PCB No. 11-86 (Ill.Pol.Control.Bd. May 23, 2011) (hereafter cited as PCB No. 11-86).
3. On June 28, 2011, the hearing officer issued an order stating that a hearing in this matter will be held on August 4, 2011 and establishing a schedule for pre-hearing

motions and post-hearing briefs. Hearing Officer Order, PCB No. 11-86

(Ill.Pol.Control.Bd. June 28, 2011).

4. On July 5, 2011, the hearing officer issued an order granting a joint request by the Petitioner and Respondent to extend the deadline for Respondent to file its recommendation in this matter to July 15, 2011. Hearing Officer Order, PCB No. 11-86 (Ill.Pol.Control.Bd. June July 5, 2011).

5. Petitioner and Respondent continue to discuss the issues raised in the Petition, and to allow additional time for discussions, Petitioner and Respondent request an extension of time until August 15, 2011 for Respondent to file its recommendation.

6. Petitioner and Respondent also request a status conference with the hearing officer to discuss rescheduling the hearing and revising the deadlines for post-hearing briefs given this request for extension of time to file the recommendation.

7. Petitioner and Respondent hereby request that Respondent be granted an extension until August 15, 2011 to file its recommendation.

WHEREFORE, Petitioner, EXXONMOBIL OIL CORPORATION and Respondent, the ILLINOIS ENVIRONMENTAL PROTECTION AGENCY, request that this Joint Motion for Extension of Time be granted and the hearing officer schedule a status conference to discuss rescheduling the hearing.
