

NOW COMES, Respondent Gary J. Szczeblewski for his Petition for Review

states as follows:


1. That the Respondent filed a Reimbursement Eligibility and Deductible Application on or about April 12, 2011 involving facility No. 7-025002 a/k/a Sesser Sun Mart, 203 W. Franklin Ave., Sesser, Franklin County., Illinois.
2. That prior to filing the Application for the facility the facility received a Timely Compliance Opportunity Certified Letter dated March 12, 2008.
3. That the Respondent did all the necessary testing and received permit for approval for the green tags to perform the leak testing.
4. That the Fire Marshall was scheduled to come to the facility on June 12, 2009 but did not show up.
5. That Respondent received an Administrative Order dated June 11, 2009 for the UST to be removed within 60 days.
6. That the Fire Marshall did show up on August 12, 2009 with the conclusion that more testing needed to be performed.
7. That Respondent did all the necessary testing.
8. That Complainant refused to allow the tanks to become functional after the Respondent has spent over \$100,000.00 to meet the Fire Marshall requirements.

9. That thereafter the Fire Marshall denied the grant for tank removal and cost the Respondent additional thousands of dollars.

10. That the Respondent is within 35 days for requesting a Petition for Review.

WHEREFORE Respondent pray for the Petition to be sent back to the Fire Marshall's Office for a re-determination for the grant application for removal of the tanks on the cite of the above reverence.


