NOTICE OF LIMITED WAIVER OF 120-DAY DECISION DEADLINE

NOW COMES Petitioner, UNITED STATES STEEL CORPORATION

("Petitioner"), by and through its attorneys, HODGE DWYER & DRIVER, pursuant to

35 Ill. Admin. Code § 101.308(c)(2), hereby agrees to a limited waiver of the statutory

120-day decision deadline for final action by the Illinois Pollution Control Board

("Board") in this proceeding until April 5, 2012. In support of this Notice, Petitioner states as follows:

- 1. On September 9, 2011, Petitioner filed a Petition for Variance ("Petition") from the emission limitation for recuperative reheat furnaces combusting a combination of natural gas and coke oven gas ("COG"), applicable to its Slab Reheat Furnace 4, at 35 Ill. Admin. Code Part 217, Subpart I ("NOx RACT Rule" or "Rule") pursuant to the terms and conditions outlined in the Petition for Petitioner's integrated steel mill plant located in Granite City, Illinois.
- On September 22, 2011, the Board accepted Petitioner's Petition for hearing. Board Order, *United States Steel Corporation v. Illinois EPA*, PCB No. 12-49 (Ill.Pol.Control.Bd. Sept. 22, 2011).

- 3. On September 29, 2011, Petitioner filed a Notice of Limited Waiver of 120-Day Decision Deadline agreeing to waive the decision deadline until February 16, 2012.
- 4. The current statutory decision deadline for this matter is February 16, 2012.
- 5. Petitioner hereby voluntarily agrees to a limited waiver of the statutory 120-day decision deadline until April 5, 2012, in order to conduct settlement negotiations with the Illinois EPA in this matter.

WHEREFORE, Petitioner, UNITED STATES STEEL CORPORATION, prays that the Illinois Pollution Control Board accept this limited waiver of the statutory 120-day decision deadline for final action on Petitioner's Petition for Review.
