

#### JURISDICTION

This Administrative Citation is issued pursuant to authority vested in the Illinois Environmental Protection Agency by 415 ILCS 5/1 *et. seq.*, specifically 415 ILCS 5/31.1.

#### FACTS

1. The Respondent, Greg Cain, is the present owner and occupant and in control and possession of a facility located in the County of Jackson, State of Illinois.

The facility is an open dump, operating without an Illinois Environmental
 Protection Agency Operating Permit, and designated with the Site Code # 0770405029.
 The facility is known to the Agency as the Grand Tower/Greg Cain site.

4. The Respondent has owned, occupied, controlled and/or operated the facility at all relevant times hereto.

5. On September 21, 2011, Don Terry, Field Inspector, Jackson County Health Department, inspected the facility. A true and correct copy of the inspection report, along with Mr. Terry's affidavit, are attached and incorporated herein by reference as Exhibit A.

#### VIOLATIONS

On the basis of Field Inspector, Don Terry's, direct observation, he has determined that the Respondent has caused or allowed open dumping at the above described facility in a manner that resulted in the following violations:

That on September 21, 2011, an on-site inspection of the facility disclosed the following:

1. The Respondent has caused or allowed litter at the facility in violation of 415 ILCS 5/21(p)(1).

2. The Respondent has caused or allowed the deposition of general construction or demolition debris; or clean construction or demolition debris in violation of 415 ILCS 5/21(p)(7).

#### **<u>CIVIL PENALTY</u>**

Pursuant to Section 42(b)(4-5) of the Act, 415 ILCS 5/42(b)(4-5), Respondent is subject to a civil penalty of One Thousand Five Hundred Dollars (\$1,500.00) for each of the violations identified above, for a total of <u>Three Thousand Dollars (\$3,000.00)</u>. If Respondent elects not to petition the Illinois Pollution Control Board, the statutory civil penalty specified above shall be due and payable no later than December 31, 2011, unless otherwise provided by order of the Illinois Pollution Control Board.

If Respondent elects to contest this Administrative Citation by petitioning the Illinois Pollution Control Board in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1 (2006), and if the Illinois Pollution Control Board issues a finding of violation as alleged herein, after an adjudicatory hearing, Respondent shall be assessed the associated hearing costs incurred by the Illinois Environmental Protection Agency and

the Illinois Pollution Control Board. Those hearing costs shall be assessed in addition to the Three Thousand Dollars (\$3,000.00) statutory civil penalty for each violation.

Pursuant to Section 31.1(d)(1) of the Act, 415 ILCS 5/31.1(d)(1), if Respondent fails to petition or elect not to petition the Illinois Pollution Control Board for review of this Administrative Citation within thirty-five (35) days of the date of service, the Illinois Pollution Control Board shall adopt a final order, which shall include this Administrative Citation and findings of violation as alleged herein, and shall impose the statutory civil penalty specified above.

When payment is made, checks shall be made payable in equal amounts (50% of total penalty each) to:

- County of Jackson, c/o Jackson County Treasurer, Jackson County Courthouse, Murphsyboro, Illinois 62966; and
- (2) Illinois Environmental Protection Trust Fund and mailed to the attention of Fiscal

Services, Illinois Environmental Protection Agency, 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276.

Respondent shall complete and return the enclosed Remittance Forms with payments to ensure proper documentation of payment.

If any civil penalty and/or hearing costs are not paid within the time prescribed by order of the Illinois Pollution Control Board, interest on said penalty and/or hearing costs shall be assessed against the Respondent from the date payment is due up to and including the date that payment is received. The Complainant may either initiate

proceedings against Respondent in Circuit Court or other debt collection actions to collect said penalty and/or hearing costs, plus any interest accrued.

You have the right to contest this Citation, pursuant to 415 ILCS 5/31.1. If you elect to contest this Citation, you must file a Petition For Review with the Clerk of the Illinois Pollution Control Board. A copy of the Petition For Review shall also be filed with Daniel Brenner, Assistant State's Attorney, Jackson County Courthouse, Third Floor, Murphysboro, II 62966. <u>YOUR PETITION FOR REVIEW MUST BE FILED WITHIN 35</u> DAYS OF THE DATE OF SERVICE OF THE PRESENT CITATION ON YOU. YOUR PETITION MUST STATE THE REASON(S) YOU BELIEVE THE PRESENT MATTER SHOULD NOT BE ISSUED. IF YOU FAIL TO FILE YOUR PETITION AND STATE THE REASONS THE PRESENT MATTER SHOULD NOT BE ISSUED. IF YOU FAIL TO FILE YOUR PETITION AND STATE THE REASONS THE PRESENT MATER SHOULD NOT BE ISSUED, A DEFAULT ORDER AGAINST YOU WILL BE ENTERED BY THE POLLUTION CONTROL BOARD.

#### **GENERAL REMARKS**

**Background**: On October 27, 2010, an Administrative Citation Warning Notice (ACWN) was sent to Mr. Greg Cain regarding the site known as Grand Tower / Greg Cain (1), located at 211 Fourth Street in Grand Tower (referred to in this narrative as the Site). The ACWN was sent in regards to open dumping observed at the Site that resulted in litter and the deposition of general construction or demolition debris. The waste observed was from a mobile home at the Site that had sustained damage from a tree limb falling on it and a fire. At the end of that inspection, I spoke with Mr. Cain who told me that he was in the process of purchasing the Site must be either properly disposed or recycled. I also told Mr. Cain that he should retain all receipts showing that the waste from the Site was properly disposed or recycled.

On January 12, 2011, I conducted a field visit to the Site on the basis of another complaint. I observed that the damaged mobile home was in the process of being demolished. Waste from the demolition process was scattered around the Site as well as in neighboring yards. After my field visit I went to Mr. Cain's residence located on Main Street in Grand Tower. I told Mr. Cain what I had observed at the Site. Mr. Cain said that he had hired someone to demolish the mobile home. I told Mr. Cain that he needed to tell his workers that they had to keep the waste contained. I also suggested that he rent a roll off box from a local waste hauler in which to contain and then transport the waste to an Illinois permitted landfill. I asked Mr. Cain to get the wind blown litter picked up from the site and contained by January 14, 2011. I returned to the Site on January 14, 2011 and observed that no actions had been taken to pick up the wind blown litter.

On March 3, 2011, I conducted another field visit to the site to determine whether any progress had been made to clean up the Site. At this time I observed a 20 yard roll off box at the site that was filled, a small fire with dimensional lumber being open burned and wind blown litter scattered around the site and in neighboring properties. An individual was at the Site when I arrived. I introduced myself and explained my purpose for being at the Site. He gave me his name as Roger Ellet. Mr. Ellet explained that he was cleaning up the Site for Mr. Cain. I told Mr. Ellet to stop all open burning. I gave Mr. Ellet my business card and asked him to tell Mr. Cain to call me to discuss the situation at his Site. No call was received by this inspector from Mr. Cain regarding my March 3, 2011 field visit.

**Inspection Narrative**: During the stated date and time, I conducted an inspection of the Site listed above. This inspection was made as a follow up to an observation made of the Site by this inspector from Fourth St., a public road way and the two field visits mentioned in the "Background" section above. Weather conditions at the time of the inspection were: Cloudy with moderate winds and a temperature of approximately 76°F. I was accompanied on this inspection by Kevin Gillespie of the Jackson County Health Department.

I arrived at the Site and observed that the condition of the site had not change significantly since my March 3, 2011 field visit. During my inspection, I observed that a waste pile at the south end of the Site (Site Sketch, Area A), remained (Photos #1 & #2, Site Sketch, Area A). The waste in this pile consisted of but was not limited to: cardboard, dimensional lumber, plywood, cloth, scrap metal, carpeting, vinyl siding and filled plastic trash bags.

North of the waste pile labeled "A" on the site sketch, I observed a 20 yard roll off box that had been at this location since at least March 3, 2011 (Photos #3 & #6, Site Sketch). The waste in the roll off box was uncovered, exposed to the elements and appears to have been abandoned. The abandoned waste within the 20 yard roll off box included, but was not limited to: dimensional lumber, carpeting, plywood, cardboard, fiberglass insulation, PVC pipe, scrap metal and gypsum board (Photos #3 & #6, Site Sketch).

Just north of the 20 yard roll off box I observed four waste tires that had been open dumped (Photo #4, Site Sketch).

Also north of the 20 yard roll off box I observed the remains of the demolished mobile home **(Photos #5 & #7 - #9, Site Sketch)**. The waste in this area consisted of but was not limited to: scrap metal, metal beverage cans, carpeting, dimensional lumber, particle board, fiberglass insulation, gypsum board, PVC pipe and household garbage.

The total volume of waste at the Site was approximately 50 cubic yards.

My inspection ended at approximately 11:32 a.m.




