ENFORCEMENT CASE

The Attorney General has brought a case against Smithfield Properties, L.L.C., an Illinois limited liability company, Wooton Construction, Ltd., an Illinois corporation, and Chicago Sun-Times, Inc., a Delaware corporation for violation of State pollution control rules. On October 11, 2011, the parties filed a proposed settlement agreement as to Smithfield Properties, L.L.C., an Illinois limited liability company and Wooton Construction, Ltd., an Illinois corporation. The parties agree that a hearing is unnecessary, and in accordance with State law, have requested that the settlement be adopted without holding a public hearing.

Any person desiring that a hearing be held may demand a public hearing in this case by filing a written hearing request with the Illinois Pollution Control Board within 21 days after the publication of this notice. The hearing request should refer to PCB 04-192. *People of the State of Illinois v. 
