

HEARING OFFICER ORDER

On December 8, 2011, all parties participated in a telephonic status conference with the hearing officer. The parties represented that discovery is proceeding, but that issues remain with the respondent, Illinois Environmental Protection Agency (Agency). Petitioner intends to file a motion to compel on or before December 14, 2011. The Agency's response is due to be filed on or before January 12, 2012. The petitioner stated that it will file an additional waiver of the statutory decision deadline.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on February 2, 2012, at 11:00 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


