

RESPONSE TO HEARING OFFICER'S ORDER

COMES NOW James L. Quirin, by and through his undersigned attorney, and responds to the Order of the Hearing Officer as follows:

1. To the best of his knowledge, James L. Quirin, is not a party to this case.
2. Mr. Quirin, through counsel, assumes he has been notified of this status conference as "Respondent's agent."
3. The "proposed settlement agreement" which he received earlier listed James L. Quirin as a Respondent in this matter which he believes he is not.
4. To the best of Mr. Quirin's knowledge, C. Grantham Company is no longer an active Illinois company.
5. James L. Quirin is presently under a federal EPA investigation in the Southern District of Illinois for his alleged activities associated with C. Grantham Company.
