

NOW COMES the Complainant, the Illinois Environmental Protection Agency (“Illinois EPA”), by and through its attorney, Special Assistant Attorney General Michelle M. Ryan, pursuant to 35 Ill. Adm. Code 108.402, and respectfully states as follows:

(1) On July 26, 2011, Illinois EPA issued an Administrative Citation to Respondents GAYLON L. & LOIS J. HARRELL, based on an inspection conducted on June 1, 2011.


(2) On September 2, 2011, Respondents GAYLON L. & LOIS J. HARRELL filed a Petition for Review.
