ENFORCEMENT CASE**

The Attorney General has brought a case against Zachary Isaac d/b/a Nu Shine Car Wash and Samuel Johnson, for violation of State pollution control rules. On February 10, 2012, the parties filed a proposed settlement agreement as to Samuel Johnson only. The parties agree that a hearing is unnecessary, and in accordance with State law, have requested that the settlement be adopted without holding a public hearing. Any person desiring that a hearing be held may demand a public hearing in this case by filing a written hearing request with the Illinois Pollution Control Board within 21 days after the publication of this notice. The hearing request should refer to People of the State of Illinois v. Zachary Isaac d/b/a Nu Shine Car Wash and Samuel Johnson, PCB 11-58 and should be mailed to the Clerk of the Illinois Pollution Control Board, 100 West Randolph Street, Suite 11-500 Chicago, Illinois 60601. 
