

ADMINISTRATIVE CITATION



- (1) On February 14, 2012, the Illinois EPA issued an Administrative Citation to Respondents JR's Mobile Homes, Inc., CMH Homes, Inc., and David R. Moser, based on an inspection conducted on January 9, 2012.


