

HEARING OFFICER ORDER

On March 15, 2012, a telephonic status conference was held with the hearing officer. The respondent stated that a draft of the proposed host agreement has been completed and will be forwarded to the petitioners within the next 10 days. The petitioners stated that they will file an additional waiver of the statutory decision deadline.

The parties are directed to participate in a telephonic status conference with the hearing officer on June 7, 2012, at 11:00 a.m. The status must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a motion to voluntarily dismiss is filed prior to the next status conference, the conference will be cancelled without further order.


