

HEARING OFFICER ORDER

On March 27, 2012, all parties participated in a telephonic status conference with the hearing officer. The petitioners stated that they continue to review a proposed draft permit that as addressed the issue on appeal and supplemental issues. The petitioners stated that one final review is needed, and expects the review to be completed in short order. The petitioners further stated that once the draft permit is approved and issued, they will withdraw this appeal. In the interim, the petitioners stated that they will file an additional waiver of the statutory decision deadline to and including July 26, 2012.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on April 4, 2012, at 11:00 a.m. The telephonic status conference must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




