

HEARING OFFICER ORDER

On April 5, 2012, all parties participated in a telephonic status conference with the hearing officer. Counsel for CITGO Petroleum Corporation and PDV Midwest Refining, L.L.C. (collectively, CITGO) stated that CITGO's responses to the questions set forth in the March 5, 2012, hearing officer order was filed on April 3, 2012. IT IS SO ORDERED.




