HEARING OFFICER ORDER

On July 11, 2012, the parties participated in a telephone status conference with the hearing officer. A hearing in this matter remains set for August 1, 2012. Originally, it appeared that the hearing would need to be continued until August 2 to accommodate Ameren's witness on technical issues. However, Ameren plans to have a witness for technical issues present on August 1, thus the second day may not be needed.

At hearing, Ameren will call two witnesses to present its case. Respondent and the Board may have questions for each witness. The public will then be allowed to comment. If possible, the hearing will be moved to a larger room located near the room currently scheduled, and a notice will be posted.

The decision deadline is currently September 20, 2012.
