
**HEARING OFFICER ORDER**

On July 26, 2012, all parties participated in a telephonic status conference with the hearing officer. The complainant stated that since the last status conference, meetings have been held with both Village of Hinsdale (Hinsdale) and DuPage County (DuPage). The respective respondents are deciding whether they will agree with the complainant to revisit the hiring of a consultant to evaluate certain options for reducing storm water flows.

Complainant and Hinsdale will be drafting a settlement to cover the non 55<sup>th</sup> Street issues. The complainant will forward additional discovery documents requested by DuPage. After review, DuPage intends to follow-up with the complainant.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on October 4, 2012, at 11:00 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. The complainant represented that it will notify the parties and the hearing officer of a call-in number prior to the next telephonic status conference. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


