NOTICE OF PROPOSED STIPULATION AND PROPOSAL FOR SETTLEMENT OF ENFORCEMENT CASE

The Attorney General has brought a case against Northwest Illini Feedlots Corporation, for violation of State pollution control rules. On June 8, 2012, the parties filed a proposed settlement agreement. The parties agree that a hearing is unnecessary, and in accordance with State law, have requested that the settlement be adopted without holding a public hearing.
