
**HEARING OFFICER ORDER**

On August 8, 2012, all parties participated in a telephonic status conference with the hearing officer. The complainant stated that the respondent responded to some, but not all, of its discovery. The respondent was reminded again that he must retain an attorney pursuant to Section 101.400 of the Board's procedural rules. The respondent stated that he will search for an attorney who can represent his corporation on a pro bono basis.

To that end and, by agreement, any remaining discovery schedule will be revisited at the next status conference.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on October 4, 2012, at 9:15 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




