

HEARING OFFICER ORDER

On November 15, 2012, all parties participated in a telephonic status conference with the hearing officer. The parties stated that they continue to have discussions and meetings regarding language in a draft permit and that they anticipate actually drafting a permit in the near future. The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including June 6, 2013.

IT IS SO ORDERED.




