#### RECOMMENDATION

The Illinois Environmental Protection Agency ("Illinois EPA") hereby files its Recommendation pursuant to Section 125.204 of the regulations of the Illinois Pollution Control Board, 35 Ill. Adm. Code 125.204.

- On December 23, 2011, the Illinois EPA received a request from Hodel Turkey Farm, Inc. (log number TC-20-11, Exhibit A) for an Illinois EPA recommendation regarding the tax certification of water pollution control facilities pursuant to 35 Ill. Adm. Code 125.204.

- 3. The proposed water pollution control facility in this request is located at Section 22, T27N, R1E of the 3<sup>rd</sup> PM in Woodford County, at the above street address and consist of the following:

Livestock waste management facility consists of a concrete manure pit (approximately 101' x 193' by 8' overlain by a concrete slotted floor, four-inch diameter perimeter groundwater drain and sampling port.

These pollution control facilities have the primary purpose of collecting, transporting, and storing livestock waste prior to cropland application, and are further described in Exhibit A.

4. Section 11-10 of the Property Tax Code, 35 ILCS 200/11-10 (2010), defines "pollution control facilities" as:

"any system, method, construction, device or appliance appurtenant thereto or any portion of any building or equipment, that is designed, constructed, installed or operated for the primary purpose of: (a) eliminating, preventing, or reducing air or water pollution ...or (b) treating, pretreating, modifying or disposing of any potential solid, liquid or

gaseous pollutant which if released without treatment, pretreatment modification or disposal might be harmful, detrimental or offensive to human, plant or animal life, or to property."

- 5. Pollution control facilities are entitled to preferential tax treatment, 35 ILCS 200/11-5.
- 6. Based on the information in the application and the purpose of the facilities, it is the Illinois EPA's engineering judgment that the described facilities may be considered "pollution control facilities," pursuant to 35 Ill. Adm. Code 125.200(a), with the primary purpose of eliminating, preventing, or reducing water pollution, or as otherwise provided in 35 Ill. Adm. Code 125.200, and are eligible for tax certification from the Board.

WHEREFORE, the Illinois EPA recommends that the Board issue the

requested tax certification.

Mr. Anane,

Thank you for your help with the Tax Certification. Below is answers to your questions.

- 1) The perimeter drain is in place primarily to provide access to the perimeter of the structure to be able to sample and ensure there is no contaminants leaking into the ground water. Additionally the perimeter drain is in place to drain ground water away from the building to prevent problems/damage to the structure from pressure buildup.
- 2) The drain is a 4" tile
- 3) The purpose of the sampling port is to ensure there are no contaminants leaking from the structure into the groundwater. The sample port is sampling the water in the perimeter drain.
- 4) The depth of the pit beneath the slatted floor is 8'.
- 5) The pumpouts around the building are used to remove the stored manure annually to apply on cropland. There is a removable cover over each pumpout. When the cover is removed it allows access to the pit to install a temporary pump to pump the manure out of the pit to the designated cropland to be applied on. When the pumping process is complete the covers are replaced.




