**HEARING OFFICER ORDER**

On March 11, 2013, the parties participated in a telephone status conference with the hearing officer. USEPA has decided to reopen petitioner's Title 5 permit for modifications. Petitioner expects that these matters will be resolved only through USEPA's appeals process, and possibly an appeal in circuit court. The RCRA permit appeal at issue in this case is on hold pending the resolution of petitioner's Title 5 permit.

The parties are directed to participate in a telephone status conference with the hearing officer at 9:30 a.m. on September 9, 2013. The status conference shall be initiated by the petitioner.

Petitioner filed an open waiver of the decision deadline.
