

NOW COMES the Complainant, the Illinois Environmental Protection Agency ("Illinois EPA"), by and through its attorney, Special Assistant Attorney General Michelle M. Ryan, pursuant to 35 Ill. Adm. Code 101.500, and respectfully states as follows:

(1) On December 10, 2008 , Illinois EPA issued an Administrative Citation to Respondents, Theodore and Sally Jackson ("Respondents"), based on an inspection conducted on October 28, 2008.


(2) On January 14, 2009, Respondents filed a timely petition for review contesting this Administrative Citation.


