NOW COMES Respondent, PACKAGING PERSONIFIED, INC., by ROY HARSCH, ESQUIRE, and responds to the Complainant's Motion *in Limine* to admit published material authored by Richard Trzupek as evidence in this matter.

PUBLICATIONS OF RICHARD TRZUPEK

Respondent has no objection to the admission of the book chapter cited by Complainant in its Motion in Limine, although the introduction of this material is merely a ploy meant to distract the Board from the sound science that underlies Mr. Trzupek's stack test methods and calculations. The fact that the Complainant disagrees with Mr. Trzupek's viewpoint about environmental regulation is not a basis for disqualifying his technical or scientific judgment, nor does it diminish the validity of his professional opinion.

Respondent takes issue with Complainant's characterization of the contents of the chapter, and with Complainant's implication that this chapter is representative of Mr. Trzupek's general views on environmental regulation. Respondent believes that in order to present the Board with an accurate representation of Mr. Trzupek's views, a larger sampling of his publications is necessary. Respondent hereby cross-moves to admit the additional publications

by Mr. Trzupek that are set forth in Exhibit A, attached hereto. These documents include articles as well as Congressional testimony by Mr. Trzupek that show that he has consistently taken the position that environmental regulation must be based on true science and not on the popular beliefs of the moment.
