HEARING OFFICER ORDER

On May 9, 2017, the parties participated in a telephone status conference with the hearing officer. The parties met on May 4, 2017, and continue to make progress on the PSD permit application. American Bottom Conservancy (ABC) expressed frustration with the slow pace of this appeal, as well as the limited information petitioner will provide about the PSD permit. Petitioner and ABC disagree about whether the PSD permit is relevant to this docket. Petitioner asserts that the PSD permit is a prerequisite to the Title V permit, but the PSD permit has not been appealed to the Board, and is not directly relevant to this docket. With no motions pending before the Board or Hearing Officer, the issue could not be resolved at a status call. Petitioner and respondent will meet again in August.

The parties are directed to participate in a telephone status conference with the hearing officer at 9:30 a.m. on August 14, 2017. The status conference shall be initiated by the petitioner.

The parties consent to electronic service, and the decision deadline is December 31, 2017.
