AMENDED HEARING OFFICER ORDER

A telephonic status conference was held on September 28, 2017. Complainant did not appear due to a family emergency. Counsel for complainant did, however, e-mail me a "Notice of Withdrawal" on the same date and asked me to file it for him. Because counsel's notice of withdrawal was not accompanied by a notice of filing nor a service list as required by Section 101.304 of the Board's procedural rules, it cannot be properly filed. Counsel informed me that a notice of filing with a service list including the address of his client would be filed by October 3, 2017.

On October 6, 2017, counsel for complainant did file a proper notice of withdrawal including complainant's address.

Counsel for respondent did appear at the conference call. Counsel stated that they need complainant's address to serve her since complainant's counsel will be withdrawing from the case.

To that end, any deadlines for answering the request to admit or responding to the outstanding motions, including responding to respondent's motions for clarification and reconsideration filed August 24 and 25, 2016, are stayed.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on October 30, 2017, at 1:30 p.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, respondent files a motion to dismiss, the conference call will be cancelled without further notice.
