**ILLINOIS ENVIRONMENTAL PROTECTION AGENCY'S MOTION FOR
EXTENSION OF TIME TO FILE A RECOMMENDATION**

NOW COMES the Illinois Environmental Protection Agency (Agency or Illinois EPA), by and through one of its attorneys, Sara G. Terranova, pursuant to 35 Ill. Adm. Code 101.500 and 101.522, requests that the Illinois Pollution Control Board (Board) grant Illinois EPA additional time to file a recommendation in the instant alternative thermal effluent limitations proceeding. In support of this motion, the Illinois EPA states as follows:

1. On December 15, 2017, Marathon Petroleum Company LP (Marathon or Petitioner) filed a petition asking the Board to approve alternative thermal effluent limitations for discharge to the Robinson Creek from the integrated refinery.
2. Pursuant to Section 106.1145 of the Board's rules, the Agency must file with the Board a recommendation within 45 days after the filing of a petition for an alternative thermal effluent limitation. *See* 35 Ill. Adm. Code 106.1145.
3. At the request of the Illinois Department of Natural Resources (IDNR), Illinois EPA and IDNR are working together to coordinate a recommendation regarding Marathon's alternative thermal effluent limitations petition. To further facilitate

this coordination between the two agencies, Illinois EPA requests additional time of 30 days to file its recommendation.

5. Petitioner has no objection to the Agency's motion for extension of time to file a recommendation.

WHEREFORE, the Illinois EPA requests a 30-day extension to file its recommendation.
