## Letter from the Chairman

In July, the Board took action in rulemakings that generated widespread public interest and comment. The actions in these recent rulemakings are summarized below. As always, information about these proceedings is available through the Clerk's Office Online (COOL) at our Web site at <a href="https://www.ipcb.state.il.us">www.ipcb.state.il.us</a>.

On August 7, 2014, the Board adopted amendments in <u>In the Matter of: Concentrated Animal Feeding Operations (CAFOs): Proposed Amendments to 35 Ill. Adm. Code Parts 501, 502, and 504 R 12-23. The amendments make the Board's rules consistent with, and as stringent as, the current federal CAFO regulations. The Board also opened a new subdocket to address whether specified unpermitted CAFOs should be required to submit certain information to the IEPA. The Joint Committee on Administrative Rules (JCAR)</u>



recommended that the Board use the subdocket also to address matters raised in a letter to JCAR from the Natural Resources Conservation Service (NRCS) of the United States Department of Agriculture. The letter raised concerns that the rulemaking may include elements of NRCS standards that are now obsolete.

In August the Board also ruled on two cases involving siting of pollution control facilities. On August 7, 2014, the Board found that Mclean County did not have jurisdiction to hear an application by Henson Disposal, Inc. for approval of the siting of a pollution control facility that recycles construction and demolition materials. American Disposal Services of Illinois, Inc. v. County Board of McLean County, Illinois, Henson Disposal, Inc. and TKNTK, LLC, PCB 11-60. The Board found that the applicant failed to complete the statutorily required service on property owners within 250 feet of the site before filing the application.

On August 21, 2014, the Board affirmed the siting of a transfer station by the Village of Round Lake Park. <u>Timber Creek Homes, Inc. v. Village of Round Lake Park, Round Lake Park Village Board and Groot Industries, Inc.</u>, PCB 14-99. The Board found that the proceedings were fundamentally fair and the Village Board's decision on each of the criteria was not against the manifest weight of the evidence.

## **Appellate Update**

In an unpublished summary order issued on August 22, 2014, the First District Appellate Court affirmed the Board's denial of Chicago Coke Company's request for attorney fees under the Administrative Procedure Act (APA). Chicago Coke Co. v. Illinois Environmental Protection Agency, Natural Resources Defense Council, Sierra Club, and Illinois Pollution Control Board, 2014 IL App (1st) 132704-U. After the Board found in docket PCB 10-75 that the Illinois Environmental Protection Agency's policy on emission reduction credits was an invalid "rule" because the policy was never properly promulgated, Chicago Coke sought litigation expenses under Section 10-55(c) of the APA (5 ILCS 100/10-55(c) (2012)). Section 10-55(c) requires a "court" to award reasonable litigation expenses, including reasonable attorney's fees, to the party bringing the action who has an administrative "rule" invalidated "by a court." The Board denied Chicago Coke's request because the Board is not a "court." In affirming the Board, the First District found that the Board's July 25, 2013 order "adequately explains the decision" and that "[n]o error of law appears of record." Chicago Coke, 2014 IL App (1st) 132704-U, ¶¶ 2, 3, citing Ill. S. Ct. R. 23(c)(5) and (6). Chicago Coke has until various dates in September 2014 to seek rehearing in the appellate court or petition for leave to appeal to the Illinois Supreme Court.

## **Rulemaking Update**

#### **Board Adopts Amendments to CAFO Regulations, R12-23**

On August 7, 2014, the Illinois Pollution Control Board (Board) adopted a final opinion and order to amend Parts 501, 502, and 504 of the Board's agriculture-related water pollution regulations. The Illinois Environmental Protection Agency (IEPA) initiated this rulemaking to make the Board's regulations consistent with, and as stringent as, the current federal regulations for concentrated animal feeding operations (CAFOs). IEPA also sought to establish state technical standards required by the federal regulations. This rulemaking was docketed as Concentrated Animal Feeding Operations (CAFOs): Proposed Amendments to 35 Ill. Adm. Code Parts 501, 502, and 504, R12-23.

The Joint Committee on Administrative Rules (JCAR) issued a certification of no objection to the Board's rules based upon agreements reached during second-notice review. In response to JCAR, the Board opened a subdocket to address whether specified unpermitted CAFOs should be required to submit certain information to IEPA. JCAR recommended that the Board use the subdocket also to address matters raised in a letter to JCAR from the Natural Resources Conservation Service of the United States Department of Agriculture. In its August 7, 2014 decision, the Board stated that it will, at a later date, issue an order addressing procedures, deadlines, and other matters in the subdocket, R12-23(A).

## Board Extends Stay of Site-Specific Rulemaking Addressing the Closure of Coal Combustion Waste Surface Impoundments, R13-19

The Board, on August 7, 2014, granted a one-year stay of the site-specific rulemaking docketed as <a href="Site-Specific Rule for the Closure of Ameren Energy Resources Ash Ponds: Proposed New 35 Ill. Adm. Code 840, Subpart B, R13-19. On April 9, 2013, Ameren Energy Resources filed on behalf of Ameren Energy Resources Generating, AmerenEnergy Generating Company, and Electric Energy, Inc. (collectively AER) a proposal to add a Subpart B to Part 840 of the Board's regulations. Part 840 addresses the closure of coal combustion waste (CCW) surface

impoundments. AER stated that its rulemaking proposal is intended to allow it to close approximately 16 surface impoundments used for CCW management at eight coal-fired power plants owned by AER.

On July 25, 2013, the Board granted AER's motion to stay the rulemaking for one year, allowing IEPA time to work on an ash pond closure rule that would apply state-wide. During the stay, Illinois Power Resources, LLC (IPR) and Ameren Energy Medina Valley Cogen, LLC (Medina Valley) acquired ownership of, or indirect ownership interest in, the facilities that are subject of the site-specific rulemaking. Additionally, IEPA filed the proposal for a generally-applicable rule, which the Board docketed as <a href="Coal Combustion Waste">Coal Combustion Waste (CCW)</a> Ash Ponds and Surface <a href="Impoundments at Power Generating Facilities">Impoundments at Power Generating Facilities</a>, R14-10. To gain more certainty regarding the proposal in R14-10, which has not proceeded to first notice, IPR and Medina Valley sought to extend the stay of the site-specific rulemaking. The Board extended the stay of R13-19 at the companies' request through August 7, 2015, and required them to file a status report every three months during the stay.

#### Board Dismisses Three Reserved "Identical-in-Substance" Rulemaking Dockets as Unnecessary

Every six months, the Board reserves a series of dockets to adopt Board rules under Section 7.2 of the Environmental Protection Act (Act) (415 ILCS 5/7.2 (2012)). The Board rules must be "identical in substance," as defined in Section 7.2, to any rules adopted by the United States Environmental Protection Agency (USEPA) to implement various programs. On August 7, 2014, the Board dismissed as unnecessary the following dockets reserved to consider rules adopted by USEPA during the period of January 1, 2014 through June 30, 2014. As USEPA did not amend its rules during the update period, no amendments are needed to Board rules.

**UST Update, R15-2.** Section 22.4(d) of the Act (415 ILCS 5/22.4(d) (2012)) relates to underground storage tank (UST) regulations promulgated by USEPA pursuant to Section 9003 of the federal Resource Conservation and Recovery Act of 1976 (RCRA) (42 U.S.C. §§ 6991b (2011)) to implement Subtitle I of RCRA (42 U.S.C. §§ 6991 *et seq.* (2006)), with certain limitations. USEPA has codified its UST regulations at 40 C.F.R. 280 through 282.

**Wastewater Pretreatment Update, R15-3.** Section 13.3 of the Act (415 ILCS 5/13.3 (2012)) relates to wastewater pretreatment regulations that USEPA adopted to implement Sections 307(b), (c), and (d) and 402(b)(8) and (b)(9) of the Federal Water Pollution Control Act (FWPCA) (33 U.S.C. §§ 1317(b), (c), and (d) and 1342(b)(8) and (b)(9) (2011)). USEPA has codified the federal wastewater pretreatment rules at 40 C.F.R. 400 through 499.

**UIC Update, R15-7.** Section 13(c) of the Act (415 ILCS 5/13(c) (2012)) relates to underground injection control (UIC) regulations that USEPA adopted to implement provisions of the Safe Drinking Water Act (42 U.S.C. §§ 300h *et seq.* (2011)). USEPA has codified its UIC regulations at 40 C.F.R. 144 through 148.

#### Board Proposes "Identical-in-Substance" RCRA Subtitle D Update for Public Comment, R15-8

On August 21, 2014, the Board adopted a proposal for public comment in an identical-in-substance rulemaking. The Board proposed updates to "incorporations by reference" in the Illinois Resource Conservation and Recovery Act (RCRA) Subtitle D Municipal Solid Waste Landfill (MSWLF) regulations. The rulemaking is docketed as RCRA Subtitle D (Municipal Solid Waste Landfill) Update, USEPA Amendments (January 1, 2014 through June 30, 2014), R15-8. USEPA did not amend its RCRA Subtitle D MSWLF regulations during the period of January 1, 2014 through June 30, 2014. Rather, the Board determined that the amendments are needed to ensure that the Illinois regulations are identical-in-substance to the federal requirements from which the Board derived them.

This proposal for public comment would update the version of federal regulations incorporated by reference to the latest version of the *Code of Federal Regulations*. The incorporations by reference in 35 Ill. Adm. Code 810.104 relate to the RCRA Subtitle D MSWLF regulations. This proposal would also correct Appendix A to 35 Ill. Adm. Code 814 as adopted in RCRA Subtitle D Amendments (Amendments to 35 Ill. Adm. Code 810, 811, and 814), R93-10 (Sep. 15, 1993).

The Board will receive public comments on this proposal for a period of 45 days following its publication in the *Illinois Register*. After that time, the Board will immediately consider adopting the amendments, making any necessary changes revealed through the public comments.

The docket number for this rulemaking, R15-8, should be indicated on the public comment. Public comments must be filed with the Clerk of the Board. 
