RULEMAKING UPDATE

Board Adopts "Identical-In-Substance" Amendments for NAAQS Update, including Ozone, R16-2

On March 3, 2016, the Board adopted final amendments to Illinois' ambient air quality standards. The amendments are "identical in substance" to regulatory revisions made by the United States Environmental Protection Agency (USEPA) under the National Ambient Air Quality Standards (NAAQS). The Board's update reflects three USEPA actions that occurred during the first half of 2015, as well as three subsequent USEPA actions. The amendments, among other things, remove the 1997 eight-hour ozone NAAQS in response to USEPA adopting the implementation rule for the 2008 eight-hour ozone NAAQS. In addition, the amendments incorporate by reference methods designated for monitoring ambient air quality. USEPA designated the methods for these priority pollutants: fine particulates ($PM_{2.5}$); carbon monoxide; coarse particulates ($PM_{10-2.5}$); and ozone. The Board's final rule adoption follows a federally-required public hearing on the proposal, which the Board held by videoconference between its Chicago and Springfield offices on February 18, 2016.

Board Proposes "Identical-In-Substance" Amendments to Hazardous Waste Regulations, including the Definition of Solid Waste Rule, R16-7

On March 3, 2016, the Board proposed amendments to Illinois' hazardous waste regulations for public comment. The proposed amendments are "identical in substance" to regulatory revisions made by the United States Environmental Protection Agency (USEPA) under the federal Resource Conservation and Recovery Act (RCRA), Subtitle C (hazardous waste). The Board's update reflects several USEPA actions that occurred during the first half of 2015, as well as two USEPA actions that occurred on July 2, 2015. Among other things, USEPA significantly amended the Definition of Solid Waste Rule as it relates to recycling and reclaiming hazardous secondary materials; removed the Comparable Fuels Rule and the Gasification Rule; and expanded the Fossil Fuels exclusion from the definition of "hazardous waste" to include "uniquely associated wastes" that are generated from processes associated with combusting coal or other fossil fuels and which are disposed of with coal combustion residuals. The proposed amendments also incorporate corrections requested by the Joint Committee on Administrative Rules, corrections suggested by USEPA based upon its periodic review of Illinois' hazardous waste regulations, and additional corrections identified by the Board in reviewing those regulations.

The Board rulemaking is captioned <u>RCRA Subtitle C (Hazardous Waste) Update, USEPA</u> <u>Amendments (January 1, 2015 through June 30, 2015, July 2, 2015)</u>, R16-7.
