HEARING OFFICER ORDER

On May 22, 2014, all parties participated in a telephonic status conference with the hearing officer. The petitioner stated that it continues to work towards addressing the new limits required by the issued construction permit. A system for removal of total nitrogen from the treatment plant effluent has been installed but one of two mixers malfunctioned. The new mixer has been installed and the data points are being reviewed.

To that end, it was agreed that this matter be continued to the date and time noted below and that respondent's record is now due to be filed on or before September 22, 2014.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on August 26, 2014, at 9:30 a.m. The telephonic conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




