
AMENDED HEARING OFFICER ORDER

On December 17, 2015, all parties participated in a telephonic status conference with the hearing officer. A draft permit has been forwarded to the petitioner for review. Petitioner stated that it will comment if needed and return to the respondent. To that end, the administrative record is now due to be filed on or before March 17, 2016.

The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including June 2, 2016.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on February 25, 2016, at 11:15 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




