Midwest Generation (Enforcement, Citizens – Land) – The Board affirmed the hearing officer’s rulings to admit Exhibit 649 and to exclude Exhibit 662. The Board reserved ruling on respondent’s motion for sanctions.</u></p>	<p>3-0 Carter and Choe abstained</p>
<p><u>PCB 18-55</u></p>	<p><u>RDK Ventures LLC, v. IEPA (UST Appeal) – Having previously granted a request for a 90-day extension, the Board dismissed this matter because no underground storage tank appeal was filed on behalf of this DuPage County facility.</u></p>	<p>4-0 Choe abstained</p>
<p><u>PCB 18-68</u></p>	<p><u>People of the State of Illinois v Mid-America Truck Corporation, an Illinois d/b/a U.S. Truck Body (Enforcement – Air) – In this air enforcement action concerning a LaSalle County facility, the Board granted relief from the hearing requirement of Section 31(c)(1) of the Environmental Protection Act (415 ILCS 5/31(c)(1) (2016)), accepted a stipulation and settlement agreement, and ordered respondent to pay a total civil penalty of \$5,000 and to cease and desist from further violations.</u></p>	<p>4-0 Choe abstained</p>

PCB 18-76	<u>Niemann Foods, Inc., v. IEPA (UST Appeal)</u> – The Board granted this request for a 90-day extension of time to file an underground storage tank appeal on behalf of this Pike County facility.	4-0 Choe abstained
PCB 18-77	<u>Hey Ram, Inc., v. IEPA (UST Appeal)</u> – The Board accepted for hearing this underground storage tank appeal involving a site in Champaign County.	4-0 Choe abstained
PCB 18-78	<u>The Benedictine Society of St. Bede v. IEPA (UST Appeal)</u> – The Board accepted for hearing this underground storage tank appeal involving a site in LaSalle County.	4-0 Choe abstained


OTHER ITEMS
