During September, the Board acted in a number of its rulemaking dockets, and that activity is summarized below. As always, information about these dockets is available through the Clerk's Office Online (COOL) at the Board's Web site at <u>www.ipcb.state.il.us</u>.

On September 5, 2013, the Board adopted a proposal for public comment in <u>Definition of VOM Update, USEPA</u> <u>Amendments (January 1, 2013 through June 30, 2013)</u>, R14-7. *See* 37 Ill. Reg. 15289 (Sept. 20, 2013). Under Section 9.1(e) of the Environmental Protection Act (Act), the Board is required to exclude from the definition of "volatile organic materials" those compounds determined by USEPA to be exempt from regulation under the state implementation plans for ozone "due to negligible photochemical reactivity."

On September 5, 2013, the Board adopted a proposal for public comment in <u>National Ambient Air Quality</u> <u>Standards, USEPA Regulations (January 1, 2013 through June 30, 2013)</u>, R14-6. 37 Ill. Reg. 15457 (Sept. 20, 2013). Under Section 10(H) of the Environmental Protection Act, enacted by Public Act 97-945 and effective August 10, 2012, the Board is now required to adopt ambient air quality standards identical-in-substance to those adopted by the Unites States Environmental Protection Agency under Section 109 of the Clean Air Act.

On September 17, 2013, the Joint Committee on Administrative Rules issued its certificate of no objection to the Board's second-notice proposal in <u>Technical Corrections to 35 Ill. Adm. Code 620.420</u>, R8-18(B). In its proposal, the Board seeks to clarify amendments to the amended groundwater quality standards adopted in 2012. *See* 37 Ill. Reg. 6123 (May 10, 2013).

On September 20, 2013, the Illinois Environmental Protection Agency (IEPA) filed a rulemaking proposal docketed by the Board as <u>Proposed Amendments to Primary Drinking Water Standards: 35 Ill. Adm. Code 611.490</u>, R 14-9. The IEPA proposes to amend the rule to allow it "to accept samples analyzed by laboratories certified by another state or a federal agency when no laboratories have been certified by the State of Illinois for a particular parameter."

On September 23, 2013, the Board held a hearing in <u>Water Quality Standards and Effluent Limitations for the</u> <u>Chicago Area Waterway System (CAWS) and the Lower Des Plaines River: Proposed Amendments to 35 Ill. Adm.</u> <u>Code 301, 302, 303 and 304</u>, R8-9(D), on water quality standards and criteria for meeting proposed aquatic life uses. Additional hearings will take place in Chicago on December 17 and 18, 2013, and continue if necessary on December 19, 2013.

Rulemaking Update

<u>RCRA Subtitle C (Hazardous Waste) Update, USEPA Amendments (July 1, 2012 through December 31,</u> 2012), R13-15

On September 5, 2013, the Board adopted amendments in docket R13-15 that update the Illinois hazardous waste regulations to include amendments adopted by the United States Environmental Protection Agency (USEPA) under the Resource Conservation and Recovery Act. Normally, the focus of this type of proceeding would be USEPA amendments that occurred during the second half of calendar year 2012. During this time, however, USEPA did not amend its regulations in a way that would require Board action. Notwithstanding, the Board adopted amendments that are necessary for two purposes within the scope of the Board's statutory "identical-in-substance" mandate: (1) incorporating corrections that USEPA has communicated to the Board as being necessary to make the Illinois regulations at least as stringent as and not inconsistent with the federal hazardous waste requirements; and (2) updating incorporations by reference of federal regulations upon which the hazardous waste requirements depend so that the Illinois regulations do not become less stringent than or inconsistent with the federal hazardous waste requirements.

The Board has further included limited corrective amendments that are not directly derived from USEPA amendments. Notably, the Board has adopted the following: (1) corrections to incorporations by reference in the text; (2) corrections of cross-references in the text; (3) removal of an obsolete provision relative to Performance Track member facilities; and (4) correction of a technical abbreviation to standard format.

The Board will delay filing these amendments with the Office of Secretary of State for 30 days from the date of the opinion and order, unless USEPA earlier expressly waives that review period. This delay is part of the agreement between USEPA and the State. The purpose is to allow USEPA time to review and comment on the adopted amendments before the Board files them.

National Ambient Air Quality Standards, USEPA Regulations (January 1, 2013 through June 30, 2013, July 3, 2013, and August 5, 2013), R14-6

In docket R14-6, on September 5, 2013, the Board adopted for public comment a rulemaking proposal to update the ambient air quality standards in the Board's air pollution regulations (35 III. Adm. Code 243) to include revisions to the National Ambient Air Quality Standards (NAAQS). The revisions were adopted by the United States Environmental Protection Agency (USEPA) pursuant to section 109 of the Clean Air Act (42 U.S.C. § 7409 (2011)) during the period January 1, 2013 through June 30, 2013 and on July 3, 2013 and August 5, 2013. With R14-6, the Board proposes the first update to the initial amendments undertaken by the Board to fulfill a new "identical-in-substance" mandate adopted in P.A. 97-945 (eff. Aug. 10, 2012). That mandate is designed to ensure that Illinois' regulations reflect USEPA's most recent NAAQS. The Board adopted the initial amendments in <u>National Ambient</u> <u>Air Quality Standards, USEPA Regulations (through December 31, 2012)</u>, R13-11 (July 25, 2013), which were effective on July 29, 2013. *See* 37 III. Reg. 12882 (Aug. 9, 2013).

The Board proposal for public comment would amend segments of the Illinois ambient air quality standards to reflect revisions and USEPA actions that affect the federal NAAQS codified in 40 C.F.R. Part 50. The Board intends the Illinois ambient air quality standards adopted in this proceeding to be identical-in-substance to their federal counterparts, as "identical-in-substance" is defined by Section 7.2(a) of the Environmental Protection Act (415 ILCS 5/7.2(a) (2012)).

The Board invites public comment on the proposed amendments. The Board will receive public comments until at least 45 days after a notice of these proposed amendments appears in the *Illinois Register*. Anyone may file a public comment with the Board at: Office of the Clerk, Pollution Control Board, James R. Thompson Center, 100 W. Randolph Street, Suite 11-500, Chicago, Illinois 60601. Public comments can also be filed electronically using the Clerk's Office On-Line (COOL) system, linked on the Board's Web page, at <u>www.ipcb.state.il.us</u>. All comments relating to this rulemaking should clearly refer to docket R14-6.

The Board has scheduled a public hearing to occur in this rulemaking for the purpose of allowing interested members of the public to comment on the proposed amendments and the anticipated State Implementation Plan (SIP) revision that would result from their adoption. The Board will conduct that hearing by videoconference between the Board's offices in Chicago and Springfield at 1:00 p.m., October 31, 2013. Hearing information follows:

Definition of VOM Update, USEPA Regulations (January 1, 2013 through June 30, 2013 and August 28, 2013), R14-7

In docket R14-7, on September 5, 2013, the Board adopted a proposal for public comment that would add four compounds to the list of those exempted from the definition of volatile organic material (VOM). The proposed amendments respond to three USEPA actions that resulted in a single set of USEPA amendments to the federal definition of "volatile organic compound" (VOC) codified at 40 C.F. R. § 51.100(s). VOM in Illinois rules has the same meaning as does VOC in the federal regulations. *Compare* 35 Ill. Adm. Code 211.7150 *with* 40 C.F.R. § 51.100(s) (2013).

The Board scheduled a public hearing to allow interested members of the public to comment on the proposed amendments and the anticipated SIP revision that would result from their adoption. The Board will simultaneously conduct the hearing at two locations by videoconference at 1:15 p.m., October 31, 2013. Hearing information follows:

Gasoline Volatility Standards and Motor Vehicle Refinishing; Proposed Amendments to 35 Ill. Adm. Code Parts 211, 215, 218, and 219, R12-24

In docket R12-24, on September 19, 2013, the Board ordered the Clerk of the Board to cause publication of an Expedited Correction with the Office of the Secretary of State. On January 24, 2013, the Board adopted a final opinion and order in this docket, directing the Clerk to submit the adopted rules to the Secretary of State, to become effective upon filing. By letter dated February 2, 2013, the Secretary of State indicated that the adopted rules were published in volume 37, Issue 6 of the *Illinois Register*. By letter dated March 15, 2013, the Secretary of State issued a Notice of Request for Expedited Correction, which provided that the word "(Repealed)" was inadvertently placed behind Section 215.612 in the table of contents for the adopted rules published in the *Illinois Register*. The Notice indicated that the Joint Committee on Administrative Rules (JCAR) would use the Expedited Correction process to correct this non-substantive error in the rulemaking. On April 16, 2013, JCAR notified the Board that the request for expedited correction was considered at the April 16, 2013 JCAR meeting and the Expedited Correction may be filed with the Secretary of State.


