
**HEARING OFFICER ORDER**

On April 3, 2014, a telephonic status conference was held. The respondent did not appear. The petitioners stated, as they did at the last status conference, that the approval process by the United States Environmental Protection Agency and the Illinois Environmental Protection Agency (Agency) regarding the related draft permits has been completed. The Agency will now commence in issuing the permits.

The petitioners stated that they intend to file a motion to amend the caption to reflect the change in ownership.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on July 24, 2014, at 10:15 a.m. The telephonic status conference must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




