
**HEARING OFFICER ORDER**

On February 18, 2016, all parties participated in a telephonic status conference with the hearing officer. The parties stated that they have negotiated revisions regarding this or other related permit appeals before the Board and continue to make excellent progress on the remaining related appeals. The parties were directed to file a response, either jointly or otherwise, to the question of the timeframe for the resolution of this appeal, on or before March 14, 2016.

The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including August 4, 2016.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on April 7, 2016, at 10:00 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




