ORDER OF THE BOARD (D. Glosser):

On December 2, 2013, the Illinois Environmental Protection Agency (Agency) filed a recommendation that the Board certify a certain facility of Dynegy Midwest Generation, Inc. (Dynegy) as a "pollution control facility" for preferential tax treatment under the Property Tax Code. *See* 35 ILCS 200/11-5 *et seq.* (2012); 35 Ill. Adm. Code 125. The facility is associated with Dynegy's Wood River Power Station, a coal- and natural gas-fired station for generating electricity (Wood River Station), which is located at No. 1 Chessen Lane in Alton, Madison County. In this order, the Board describes the legal framework for tax certifications, discusses the Agency's recommendation, and certifies that Dynegy's mercury sorbent trap monitoring system for Unit Number 5, Boiler Number 5, at Wood River Station is a pollution control facility.

LEGAL FRAMEWORK

Under the Property Tax Code, "[i]t is the policy of this State that pollution control facilities should be valued, at 33 1/3% of the fair cash value of their economic productivity to their owners." 35 ILCS 200/11-5 (2012); *see also* 35 III. Adm. Code 125.200(a)(2). "For tax purposes, pollution control facilities shall be certified as such by the Pollution Control Board and shall be assessed by the Department [of Revenue]." 35 ILCS 200/11-20 (2012); *see also* 35 III. Adm. Code 125.200(a).

Under Section 125.202 of the Board's procedural rules, a person may submit an application for tax certification to the Agency. *See* 35 Ill. Adm. Code 125.202. If the Agency receives a tax certification application, the Agency must file with the Board a recommendation on the application, unless the applicant withdraws the application. *See* 35 Ill. Adm. Code 125.204(a). Among other things, the Agency's filing must recommend that the Board issue or deny tax certification. *See* 35 Ill. Adm. Code 125.204(a)(4). If the Board finds "that the claimed facility or relevant portion thereof is a pollution control facility . . ., the Pollution Control Board

... shall enter a finding and issue a certificate to that effect." 35 ILCS 200/11-25 (2012); see also 35 Ill. Adm. Code 125.216(a).

AGENCY RECOMMENDATION

The Agency states that it received a tax certification application from Dynegy on or about October 20, 2008. Rec. at ¶ 1. The Agency explains that it had misplaced Dynegy's application. *Id.* On December 2, 2013, the Agency filed a recommendation on the application with the Board, attaching Dynegy's application (Rec. Exh. A). The Agency's recommendation identifies the facility at issue:

The subject matter of this request consists of a Mercury Sorbent Trap Monitoring System, which was constructed and installed by Dynegy [] on Unit No. 5, Boiler No. 5 of the Wood River Station. According to the application, the project was implemented to comply with the requirements of the Illinois mercury rule promulgated by the Board. Rec. at \P 4.

The Agency further describes the facility: "As generally recognized in the field of air pollution control technology, a sorbent trap monitoring system is designed for automated, continuous sampling of vapor-phase mercury emissions from stationary sources and is an integral part of mercury emissions control." Rec. at ¶ 4; see also Rec. Exh. B (Agency technical memorandum). According to Dynegy's application, Powder River Basin Wyoming Coal is combusted in Boiler Number 5, which is associated with Unit Number 5. Rec. Exh. A at 1.

The Agency recommends that the Board certify that the identified mercury sorbent trap monitoring system is a pollution control facility as defined in Section 11-10 of the Property Tax Code (35 ILCS 200/11-10 (2012)), with the primary purpose "to serve as an integral part of, or appurtenance to, mercury emission controls that prevent or reduce air pollution." Rec. at \P 7, 8.

TAX CERTIFICATE

Based upon the Agency's recommendation and Dynegy's application, the Board finds and certifies that Dynegy's mercury sorbent trap monitoring system identified in this order is a pollution control facility under the Property Tax Code (35 ILCS 200/11-10 (2012)). Under Section 11-25 of the Property Tax Code, the effective date of this certificate is "the date of application for the certificate or the date of the construction of the facility, which ever is later." 35 ILCS 200/11-25 (2012); see also 35 Ill. Adm. Code 125.216(a). Section 125.216(d) of the Board's procedural rules states that the Clerk "will provide the applicant and the Agency with a copy of the Board's order setting forth the Board's findings and certificate, if any." 35 Ill. Adm. Code 125.216(d) (quoting in italics 35 ILCS 200/11-30 (2012)). The Clerk therefore will provide Dynegy and the Agency with a copy of this order.

IT IS SO ORDERED.

Section 11-60 of the Property Tax Code provides that any applicant or holder aggrieved by the issuance, refusal to issue, denial, revocation, modification or restriction of a pollution

control certificate or a low sulfur dioxide emission coal fueled device certificate may appeal the Board's finding and order to the Circuit Court under the Administrative Review Law (735 ILCS 5/3-101 *et seq.* (2012)). *See* 35 ILCS 200/11-60 (2012).
