**HEARING OFFICER ORDER**

On January 6, 2016, the parties and the intervenor participated in a telephone status conference with the hearing officer. Petitioner continues to meet with respondent on a PSD permit application that is not related to any permit pending before the Board. The parties have met three times and held several conference calls in the last six months. Petitioner cannot guess as to a timeframe for the PSD permit due to respondent's personnel constraints and the facility's shift to an idle mode. Petitioner agreed to file a deadline waiver to December 31, 2016.

The parties are directed to participate in a telephone status conference with the hearing officer at 9:30 a.m. on July 12, 2016. The status conference shall be initiated by the petitioner.

The decision deadline is June 30, 2016.
