In accordance with the requirements of 35 Ill. Adm. Code 104.216, the IEPA filed its Recommendations on April 5, 2019. The Village provides the following comments on questions concerning the portions of the Recommendation referenced below:

#### Attachment 1, "TLWQS Conditions"

In condition (a), the Village seeks clarification as to what kind of information will be gathered for re-evaluation and how such information will be gathered.

In condition (c), the Village requests that this condition be defined in more detail concerning the referenced re-evaluation, highest attainable condition, and the nature of the information required.

In condition (d), the Village requests clarification on the frequency and duration of the referenced data collection period.

In condition (f), the Village requests clarification on whether and how costs to prepare the requested annual report are to be allocated among the various Petitioners.

In condition (h), the Village requests that this condition specify that such BMPs are mandatory for any covered discharger if applicable and fiscally possible to implement.

In condition (i), the Village requests clarification as to whether financial limitations are to be considered when evaluating new or innovative technologies.

### Attachment 3, "BMP's for MS4s /CSO Communities"

In BMP 7 on page 4, the Village requests that this BMP define the time period for implementation.

In BMP 13 on page 4, the Village requests clarification as to whether the referenced annual report is to be developed by each MS4.
