I'm not sure how much leverage we have but I was hoping you could help pin down an acceptable date for Clean Air and Water to return to Powerton to correct a section of miss installed liner. I don't know if CAAWS has committed to a return time for the other MWG site, but Craig Wilson from Terra is having trouble pinning down CAAWS to a schedule. Please see the email string below. Our goal was to be done October 1 well ahead of the October 24, deadline, so there is still time within reason. Terra was planning to start demobilizing next week and keeping them mobilized will cost us money and the delay will push us closer to our deadline.
