

**HEARING OFFICER ORDER**

On March 9, 2016, all parties participated in a telephonic status conference with the hearing officer. Discussion centered on petitioner's discovery requests that were served on February 16, 2016. The parties agreed that they will discuss the scope of the propounded discovery and the discovery responses in an attempt to resolve any differences by March 21, 2016. The parties will then submit a report outlining the discovery resolutions, if any, on or before March 21, 2016. To that end, the timeline for discovery and responses will be held in abeyance.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on March 24, 2016, at 1:30 p.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
