
HEARING OFFICER ORDER

On June 20, 2016, all parties participated in a telephonic status conference with the hearing officer. The parties stated that they have reviewed the Board's June 16, 2016 order. Petitioner will attempt to respond to the Board's questions sooner than the Board's briefing schedule set forth in the order.

Petitioner stated that it does not appear that it will file an additional waiver to the statutory decision deadline due to time constraints regarding implementation dates. As a consequence, the parties were informed that a hearing will be scheduled at the next status conference noted below. In the interim, the parties will inquire about witness availability. The hearing will be scheduled for either August 2 or 3, 2016, with the record closing on August 10, 2016. Based on this timeline, the parties may have two days or less to file their respective post-hearing briefs.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on June 28, 2016, at 11:00 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


