

HEARING OFFICER ORDER

On April 29, 2015, the parties submitted an agreed and revised discovery schedule. The revised discovery schedule is accepted to the extent as follows. Complainants must disclose expert witnesses on or before June 1, 2015. Complainants' written expert witness report must be served on or before July 1, 2015. Respondent must disclose expert witnesses on or before August 1, 2015. Respondent's written expert witness report must be served on or before September 1, 2015. Complainants' written expert witness reply must be served on or before October 1, 2015. Depositions of expert witnesses must begin no earlier than November 1, 2015 and completed by February 1, 2016. Dispositive motions must be filed on or before April 1, 2016.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on June 11, 2015, at 11:30 a.m. The telephonic conference must be initiated by the complainants, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


