






HEARING OFFICER ORDER

On March 12, 2015, all parties participated in a telephonic status conference with the hearing officer. The parties stated that they have negotiated revisions regarding this or other related permit appeals before the Board and continue to make progress on the remaining related appeals. The petitioner stated that it will file an additional waiver of the statutory decision deadline to an including October 25, 2015.

IT IS SO ORDERED.




