NOTICE OF LIMITED WAIVER OF 120-DAY DECISION DEADLINE

NOW COMES Petitioner, GBL PROPERTIES, INC. (“Petitioner), by and through its attorneys, HEPLERBROOM, LLC, pursuant to 35 Ill. Adm. Code 101.308(c)(2), and hereby agrees to a limited waiver of the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board (“Board”) in this proceeding until May 21, 2020. In support of this Notice, Petitioner states as follows:

1. On August 6, 2019, Petitioner filed a Petition for Review of Agency Determination (“Petition”) of the Illinois Environmental Protection Agency’s July 5, 2019 decision regarding Petitioner’s Application for Payment from the Underground Storage Tank (“UST”) Fund.
2. On August 22, 2019, the Board accepted the Petition for hearing.
3. The current decision deadline for this matter is November 21, 2019.
4. Petitioner hereby voluntarily agrees to a limited waiver of the statutory 120-day decision deadline until May 21, 2020.

WHEREFORE, Petitioner, GBL PROPERTIES, INC., prays that the Illinois Pollution Control Board accept this limited waiver of the statutory 120-day decision deadline for final

action on Petitioner's Petition for Review of Agency Determination.
