**HEARING OFFICER ORDER**


On November 5, 2015, all parties participated in a telephonic status conference with the hearing officer. Discussions centered on respondent's written motion for extension of time to file its response to petitioner's motion for summary judgment. Respondent's motion was filed October 29, 2015. The respondent requested additional time to and including December 9, 2015.

The petitioner objected to the extension of time and further stated that it will not file an additional waiver of the statutory decision deadline. At present, the statutory decision due date is February 18, 2016.

Over objection, respondent's motion for extension of time was granted to the extent that its response is now due to be filed on or before November 20, 2015.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on November 24, 2015, at 10:00 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. A hearing date may also be discussed.
