PETITIONER IMTT'S RESPONSE TO BOARD QUESTIONS

IMTT Illinois, LLC ("IMTT") by and through its attorneys, K&L Gates, LLP, submits this response to the Board's Questions attached to the Hearing Officer's Order of July 24, 2019.

With the following exception, IMTT agrees with and adopts the Responses submitted by MWRD. That exception is the MWRD's response to the question regarding watershed workgroups.

IMTT appreciates the Board acknowledging the issue raised by IMTT but disagrees both with the Board's proposed resolution expressed in its draft order and with MWRD's response. Based on the various submissions the workgroup seems like an answer in search of a question. In its Recommendation, the Agency stated that permittees should be forced to join workgroups but that that workgroups should only be charged with outreach and educations, tasks traditionally (and by legislative direction) performed by IEPA. The Board noted the questions but then laid out an extensive set of tasks for workgroups to perform. In its response, MWRD acknowledges that workgroups should not have the tasks described by the Board or the outreach task suggested by the IEPA, but says they should only have the function of submitting annual and five year reports. Yet since the actual compliance points are limited and MWRD samples these compliance points, it is not clear why the various petitioners here have to submit one report. It ought to be sufficient that they report on their individual efforts to comply with their BMPs and discuss any suggested or needed modifications.

Neither the MWRD nor the Agency have articulated any reason why petitioners here ought to be required to join a workgroup as a condition of this variance and their NPDES permit. As a result of this requested action, participation would be mandatory under state and federal law. In the absence of any federal or state statutory authority to require participation and in the absence of any specific policy to be implemented by participation, the Board should not include this as a requirement of this variance.

In addition, IMTT previously commented to the recommended BMP now included as item 10 on Table 3 of the Board's proposed order. This requires dischargers to develop a written plan with "milestones," but IMTT commented that it does not describe what milestones are to be set.

IMTT renews that comment here.

As always, IMTT appreciates the opportunity to submit these comments.
